				pages or is intended to engage privately with members on platforms such as but not		
				limited to Facebook, Instagram, Messenger, Twitter, etc.		
				Who owns the group / page created.		
				All GNA groups and GNA pages created with the intention of communicating to Gosford		
				Netball Association members or the wider community remain property of GNA. The		
				Administrators of each group / page created must include the GNA President GNA		
				Executive Co-ordinator responsible for the group / page.		
				What rules apply		
				All GNA social media platforms must be approved by the GNA Executive prior to being set		
				up. In the event of a group / page Administrator no longer holding a position on GNA		
				Executive they must immediately transfer administration rights to the newly elected		
				Executive Coordinator and relinquish their role of Administrator on all GNA social media		
				platforms. They may then re-join any page / group as a member. Failure to comply with		
				the above may result in:		
				Suspension from ALL Gosford Netball Association activities until this has been		
				completed.		
				• In extreme circumstances legal action. Posts directly to /or shared to the GNA social		
				media platforms will be removed by an administrator if:
